### Intersessional Meetings of the **Anti-Personnel Mine Ban Convention**

#### Statement on Universalization

Geneva, 20 May 2016

Madam President,

The following statement is delivered on behalf of the Inter-Agency Coordination Group on Mine Action (IACG-MA) comprising several United Nations entities<sup>1</sup> involved in mine action.

The United Nations welcomes the intervention by Sri Lanka regarding the approval by its Cabinet of Ministers to join the Antipersonnel Mine Ban Convention, and trusts that this will lead to its accession very soon. The United Nations encourages other States that have still not joined this Convention, especially those affected by anti-personnel mines, to also consider their accession to this important instrument of international humanitarian law.

The report of the Secretary-General ahead of the first-ever World Humanitarian Summit highlighted the unacceptable impact of mines and explosive remnants of war on civilians and stressed the need for States to become parties to, and implement and comply with, relevant international humanitarian instruments. The United Nations calls upon States Parties to ensure consistency with their obligations under the APMBC and thus, actively encourages them at the World Humanitarian Summit to commit to the universalization and full implementation of the APMBC, as well as to the other international legal frameworks for mine action.

Madam President,

The Secretary-General highlighted again universalization in his message on the International Day for Mine Awareness and Assistance in Mine Action on 4 April. On that occasion, in States not party to the APMBC, the United Nations advocated for universalization through creative means. In Lebanon, for example, UNDP mobilized its
